- 1. Call to order The meeting was called to order at 7:00 p.m. by Joe Stadler

- 8. <u>Foundation Projects.</u> Lins discussed two projects from the SRC Foundation. The patio project was approved earlier this year, but the previous board. Lins stated the patio was in the original plans for the building but was cut, when trimming that budget. The second project is to install an ultraviolet light for the pool water. The installation of this light could allow for us to switch to offering a salt water pool, verses using liquid chlorine. Discussion followed. Lins was asked to bring back more information for the next meeting.
- 9. <u>Summer Programs:</u> The summer swimming lessons will begin next week. The Sharks swim team(celebrating their 25<sup>th</sup> Anniversary) has been practicing for a couple of weeks of far. Lins handed out the summer brochure. The brochure has a calendar of events. Lins invited the board members to attend a swim meet.
- 10. <u>Directors Report</u>- Tracy Gobin has been teaching lifeguard training classes, with good enrollment. The trees in the front lawn have been taken down and cleaned up. The swim team and the aerobics program each had an entry in the Rodeo parade on Saturday.
- 11. <u>Board Discussion</u> Linda Gentes asked that we discuss the option of the Maintenance staff being issued a credit card for calling in orders.
