## Symons Recreation Complex Natatorium Board Minutes October 10, 2016

- 1. Call to order The meeting was called to order at 7:00 p.m. by Joe Stadler
- 2. Proof of Notification Proof of notification was met, per Lins
- 3. <u>Approve Agenda Charles Clark made a motion to approve the agenda; John Collins seconded. The motion carried.</u>
- 4. <u>Approve Minutes Bryan Myers made a motion to approve the minutes of September 12, 2016; Linda Gentes</u> <u>seconded. The motion carried.</u> <u>John Collins made a motion to approve the minutes of September 26,2016,</u> <u>David Turk seconded. The motion carried.</u>
- 5. <u>Approve Bills -</u> Lins presented bills totaling \$3,908.89. <u>Fred Graf made a motion to approve the bills. Marie</u> <u>Rakow seconded. The motion carried.</u>
- 6. <u>Budget Overview 2016</u> Revenues are roughly the same as last year. Expenditures are up in payroll (Bonus checks) and this month with an extra pay period..
- 7. <u>Upgrade Heat /Air conditioning System.</u> Lins received the ok from the Finance Committee for Richland County and the City of Richland Center to spend up to \$30,000 from the capital improvement funds, to upgrade the heating and air conditioning system in the large exercise room. Lins informed the board that the current air conditioning system was hit by lighting and thus there is no form of cooling, other than the outside air. Bid documents will be drawn up and an ad placed in the newspaper. If everything goes well, it is possible that we will have bids to open at the next board meeting.
- 8. <u>Policy changes</u>- Lins presented a rough draft of a policy for subcontractor or volunteer persons, teaching classes at the facility. Discussion about the pro's and con's of having programming not offered by Symons staff. The board made changes to the rough draft policy and asked that the county attorney review the document and bring it back to the next meeting.
