- 1. Call to Order- Chair Chad Cosgrove called the meeting to order at 7:00pm
- 2. Proof of Notification. Proof of Notification was met, per Lins
- 3. Approve Agenda- <u>John Cler made a motion to approve the agenda. Seconded by John Collins. The motion</u> carried.
- 4. Approve minutes- <u>Brandon Fetterly made a motion to accept the minutes of the July 9, 2018, meeting.</u>
 Seconded by Linda Gentes. The motion carried.
- 5. <u>Approve Monthly Bills-</u> Invoices were presented in the amount of 7,275.85. <u>John Collins made a motion</u> to pay the monthly bills. John Cler seconded the motion. The motion carried.
- 6. <u>Budget Overview-</u> Membership revenue is up from last year. Expenditures are roughly the same as last year.

- 12. <u>Solar Panel Damage-</u>Lins stated that she is getting an estimate of damages for the Solar Panels, which will be given to the Finance Committee.
- 13. <u>Update Small Claims Case</u>. The small claims suit was filed on Monday.
- 14. Change job rate for coaches and personal trainers- Lins discussed the job rate for the head swim team coaches. Lins recommended that they go from a job rate of 10.55 to \$12.52. Discussion followed. <u>John Collins made a motion to increase the wage to as close to a \$1.40 per hour increase. Brandon Fetterly seconded. The motion carried.</u>
- 15. <u>Board Discussion</u> Lins stated that she applied and received a discount to attend a week long grant-writing program in Minneapolis in September. The SRC Foundation will be paying for the training.
